



The 2024 Great Northern Concrete Toboggan Race Competitor Code of Conduct Form

Competitors are, at all times, responsible to uphold the following standards as set by the Great Northern Concrete Toboggan Race (GNCTR) 2024 Organizing Committee:

Competitors are responsible to comply with these standards of conduct as a condition of competing/participating in GNCTR 2024. These conditions are in addition to the Student Code of Conduct of each respective academic institution, as competitors are representatives of their respective institutions. Competitors who fail to comply with these standards may be subject to disciplinary action up to and including disqualification and/or removal from the competition.

Competitors shall not breach any provision of the criminal code or any other federal, provincial, or municipal statute or regulation.

Competitors are responsible for:

- Maintaining the dignity and respect of all persons and upholding the integrity of the GNCTR competition.
- Upholding the reputation of their respective teams and academic institutions and avoiding any behavior which may reflect poorly on themselves, their institution, or the competition.
- Ensuring their conduct does not endanger the mental/physical/emotional health of any person, or cause damage to equipment or facilities; violence of any kind is strictly prohibited.
 - Competitors are responsible for reporting any incidents of violence or threats; any incident or threat of violence at the competition will be addressed immediately.
- Creating and maintaining a safe and respectful environment for all competitors, by not engaging in any conduct which is discriminatory in nature; discrimination towards any person or persons on the basis of race, ethnicity, place of origin, religion, language, culture, sex, gender, sexual orientation, age, etc. is strictly prohibited. Chants which include discriminatory or demeaning language are prohibited.
- Creating and maintaining an environment of safety for all competitors by maintaining respectful personal and sexual boundaries. There is a zero-tolerance policy for violence (physical, emotional, sexual).
 - Sexual assault is any form of sexual contact without voluntary consent.
 - Sexual harassment is any unwanted sexual attention or communication that is intimidating, humiliating, or otherwise offensive.
- Avoiding situations which may place themselves or others at risk; including but not limited to horseplay, pranks, and the consumption of alcohol, cannabis, and/or drugs.
